## Texas Motorcycle Safety Coalition Meeting Minutes



## June 24, 2021

## Opening Remarks & Introduction (Chris Beireis & Mike Manser)

Mike Manser and Chris Beireis welcomed everyone to the TMSC meeting and apologized for the technical difficulties of the meeting audio in the first few minutes of the meeting. Approximately 26 people attended by WebEx or phone. An attendee list (as shown on the WebEx participant list or in the WebEx chat) and a chat transcript of the meeting are attached to these minutes.

## WebEx Refresher overview (M. Manser)

Mike demonstrated how to use the WebEx chat box to provide comments during the meeting and invited participants to contact TTI through the Contact Us page on LookLearnLive.org.

## Texas Motorcycle Safety Forum Review, 2022 Plan (Cathy Brooks)

Cathy thanked everyone for their input as we planned the Forum. One hundred sixty-four people registered, of those six registered the day of, and 11 registered after to watch the sessions. Currently, everything is posted on the LLL website, so you can go and watch each session. Please go in and watch the videos and share them so we can reach as many people as possible. Attendance ended up being around 50-60. 60% of them were motorcyclists, 20% were club members. One hundred twenty-one of registrants indicated they rode and that they have ridden over 6,000 miles!

#### 2021 Forum in Review

What are you hoping to get from the Motorcycle Safety Forum?

- Riding tips and skills to reduce your risk of crashing: 88 (65%)
- Information about motorcycle laws and legislation: 99 (73%)
- Information about motorcycle crashes, injuries, and fatalities: 101 (74%)
- Ways to promote motorcycle awareness to other drivers: 105 (77%)
- New developments in motorcycle safety: 107 (79%)
- Ideas for promoting motorcycle safety among riders: 113 (83%)

Across the board, the 2021 Session ratings received high scores concerning speaker knowledge, session content, and usefulness of the information. The breakdown of this information can be found in the PowerPoint slide posted <u>here</u>.

#### Planning for the Forum in 2022

May was the most preferred month to host the Texas Motorcycle Safety Forum in 2022. Comments included that May is a good month as it coincides with Motorcycle Safety Awareness Month. February and March in 2<sup>nd</sup>. Saturday was the #1 day that worked well.

The TMSC would like to see the event in person but would like to see a virtual option for those who can't attend. Everyone also liked being able to go back and watch the sessions. This also makes the meeting recordings available to share throughout the year on social media.

Mike Manser stated the hybrid approach helps us get speakers from around the country, and networking is a critical element of these events. He asked everyone to please share their thoughts or experience of hybrid events. Such as a video of someone presenting to a live audience/approach.

James H mentioned one option for Livestream could be our YouTube channel. This makes the meeting sessions automatically recorded and posted after the fact. Consideration of the Livestream option was popular for those who can't attend in person.

Nina mentioned she hasn't attended a hybrid event but knows this option is occurring. What they've found is that more people can show up. I think the hybrid will be a trend for conferences to get more people on board and more people to attend.

Mona Lisa indicated that TxDOT would be offering both – virtual/hybrid for her monthly meetings going forward.

#### Additional 2022 Forum Planning Feedback

- Hold the Forum as an in-person event, but if possible, include a virtual attendance option for those who cannot attend in person.
- Consider scheduling a pre-or post-Forum activity such as a ride or bike rodeo.
- Include a focus on young riders and racing bikes in some presentations.
- A variety of topics appeal to attendees; presentations about riding skills, technologies, and motorcycle-related legislation were the most popular among the topics proposed in the feedback survey.

## Task Force Activity Update (Cathy Brooks)

Cathy Brooks presented the update for the TMSC Task Force activities since the last meeting. The Task Force has examined several different rider safety topics to pursue, including rider licensing, rider training, and impaired riding. They initially will focus on impaired riding and will identify the next steps to develop an education and outreach program. The Task Force is also involved in planning the Texas Motorcycle Safety Forum, reviewing nominations for the Texas Motorcycle Safety Award, and other TMSC support.

Summary of the Topic Focus findings of Rider Impairment since last Task Force meeting:

- In and around Harris County.
- Age group, 30-39.
- 54 fatal injuries.

• Males.

Next Steps for the Task Force:

- Develop Survey to determine target behaviors and potential countermeasures
- Develop campaign strategies and materials
- Implement Pilot

Mike Manser reminded the group that the Task Force is still looking for members to continue to help identify issues and provide input to agencies like TTI and TxDOT, who can then implement solutions. Below is a brief outline of the purpose of the Task Force and how to join.

#### Purpose of the Task Force

 To help the TMSC by focusing on key motorcycle safety issues and making recommendations back to TMSC members.

 The Task Force meets quarterly (short and productive) or more frequently depending on work product and members' availability.

#### Task Force Jude Schexnyder – Legislative update

Jude Schexnyder provided an update from the Legislative Task Force and indicated it wasn't a very successful session. All four bills that were motorcycle-related died before they went to the house. Motorcycle related bills this session were:

- H.B.1837 Motorcycle profiling bill filed by Mary Gonzales of El Paso; prohibits profiling motorcycle riders by law enforcement based on riding a motorcycle, wearing motorcycle apparel, or other reasons unrelated to behaviors.
- H.B. 1838 (also filed by Gonzales) Disallows identification of an individual as a street gang member based solely on apparel/symbols worn.
- H.B. 2577 filed by Kempel of Seguin; adds electric MC to the list of vehicles eligible for a \$2500 electric vehicle incentive. However, \$750 of that \$2500 must be remitted to the State Comptroller for the highway fund.
- Bills filed by Dutton of Houston, Crockett of Dallas, Wu of Houston relate to individuals with a limited motorcycle license; changes the age from under 17 to under 18 years of age, and prohibits the use of wireless communication devices while operating a motorcycle for riders in that category.

# Texas Department of Licensing & Regulation (TDLR) update – (M. Manser)

Mike updated the TMSC on the subcontract between TDLR and TTI to help get more people to take the entry-level course and help recruit instructors. The numbers, by some measures, indicate Texas is short about 200 motorcycle instructors. One issue Texas faces when it comes to motorcycle rider classes is that it's hard to get to a rider course in more rural areas. We're also trying to find out what factors help motivate riders to become coaches. Once we have a better idea of who, what, and why coaches are inspired to become rider coaches in the first place, then we can figure out how to recruit more. The

timeline for this project is to have that Survey done and have the data revied by early-late fall, early winter—rider Coach discussion. The need is there.

#### Discussion:

Q: Who to contact if you are interested in being a rider coach. TEEX has the classes for Rider Coach. The first step is training through TEEX, then apply for a license through TDLR.

ADDED NOTE: You must complete the TEEX training before applying for a license to teach in Texas through TDLR. A first-time coach/instructor must be trained through TEEX. At this time, only the MSF Basic Rider Course (entry-level) course is being offered at TEEX. Their training site is located on the RELLIS campus of Texas A&M in Bryan. They have offered to provide training at a host school location that meets TEEX requirements. Comment: Many motor patrolmen have taught in the past, but they get busy with side gigs.

Comment on becoming a rider coach: It does cost some money, it does take some time. TEEX has three classes and finished one with eight graduates (out of 12 students), then the next two left are full. The info is through TDLR and TEEX. The prerequisite is that you need your Class M for two years and a background check. Some sponsors will help you along the way.

If you want to become an instructor, it helps to have a sponsor. Find the nearest school through TDLR (https://www.tdlr.texas.gov/mot/find-schools.htm) and take the basic rider course. Fill out an application. You'll get a background check. Once your application has been accepted, you'll be put in the class you signed up for. The course is \$250.00, and you'll be provided material to study. You generally get your basic rider course. You will be spending between 7-10 days doing the instructor prep; then, after that, there are other certifications you can get beyond that. Question: can you just be a trike instructor? The answer is yes. You can be a three or two-wheel instructor. Right now, getting inundated with trike class requests. TEEX classes are filled through October. They are filling up fast as soon as they are posted.

ADDED NOTE (Cathy Brooks): In Texas, the trike only is not currently available as all first-time instructor training must be done through TEEX, and they are not offering a class. I will verify with MSF if they offer/authorize trike-only instructors as the approved trike course provider in Texas. Please contact me if you are interested in more information. <u>C-brooks@tti.tamu.edu</u>.

Update to above note: Per MSF, as the approved trike course provider in Texas, "At the present time, the only way to acquire 3WBRC RiderCoach certification is first to become a RiderCoach for the BRC. The 3WBRC RiderCoach Guide does not have the content to stand alone for initial certification."

Jeff Alford, check TEEX. Its [prep course at TEEX in Bryan is] equally inconvenient to everyone. Which can be a barrier to becoming an instructor. Also, figuring out how to stay in Bryan for ten days and funding for that. That's where a sponsor can come in and help out.

## Federal Highway Administration Reports (M. Manser)

Mike also called attention to two reports coming out.

There is a Federal Highway Administration (FHWA) Report Out: <u>Synthesis on Barrier Design for</u> <u>Motorcycle Safety</u>. Federal Highway has been taking a serious look at how to take a look at making those safer for riders. This report talks about motorcycle-friendly barriers. Two sections of importance are looking at how to convert existing barriers to be more motorcycle rider safe and includes a list of recommendations for DOTs for implementation.

The second report from FHWA is due out in a couple of months. We will share the report with a link when it comes out. The title is: Addressing the Motorcyclist Advisory Council Recommendations: Synthesis on Roadway Geometry, Pavement Design, and Pavement Construction and Maintenance Practices.

This report came out of motorcycle council advisory and will be shared with DOTs. Texas was/is really active in developing this report, and it will help all states elevate motorcycle awareness with engineers for design consideration. It includes noteworthy practices, lessons learned and guides on implementing safer strategies for DOTs with motorcyclists in mind. Motorcycle riders are not at the top of their list. They just don't think about riders. They are looking at ways on how to raise motorcycle awareness to those that design roadways.

The second report should be available in another month or two, and we'll share that link when available.

## Updates, Open Forum, New Stuff (Cathy Brooks)

Cathy gave an update and heads up on the "I Ride for tomorrow pledge" and that the TMSC is looking at reviving and expanding the pledge.

Two outreach questions were asked: 1) how to get Motorcycle/share the road yard signs and 2) how does one reserve the "Look Twice" inflatable.

Mona Lisa indicated that she has signs and decals. "I have Share The Road yard signs. When I say I have, I mean I have thousands!! Send me an email at: <u>monalisa.didelot-page@txdot.gov</u> with the amount you want and a shipping address. We also have Share The Road decals, 4" and 9"."

The inflatable is reserved on a case-by-case basis. Reach out to Mona Lisa – send her an email and see what dates are available. Her email, once again, is: <u>monalisa.didelot-page@txdot.gov</u>

Also noted in the open discussion that there were two motorcycle fatalities in the last two weeks. One went through a cable barrier. The group was looking to Mike for a possible presentation to the coalition on how to get TxDOT involved. Do we have an inventory of our barriers in Texas?

## Invitation for Free Safety Presentations (J. Schexnyder)

Jude Schexnyder provided information on two motorcycle safety presentations that can be presented free of charge to motorcycle clubs or other gatherings/meetings. The TMSC-developed presentation, presented by Jude, includes data about motorcycle crashes and practical riding information to reduce crash risk (contact Cathy Brooks at <u>c-brooks@tti.tamu.edu</u>). The TxDOT-developed presentation, presented by Mona Lisa Didelot-Page, focuses on crash data, motorcycle gear information, hand signals that riders use to communicate on the road, and other things to help motorists be aware of rider behavior. (contact Mona Lisa at <u>monalisa.didelot-page@txdot.gov</u>).

## Upcoming Meeting and Forum Dates (M. Manser)

The TMSC Forum is on September 2, 2021. For the time being, these meetings will remain virtual; as the COVID-19 pandemic becomes less of an issue, in-person or hybrid in-person/virtual meetings may resume. Future meeting dates past September 2 will be announced in Fall 2021.
